WHEREAS, the county auditor has certified the total current tax valuation of Brookville Local School District and the dollar amount of revenue that would be generated by the proposed levy annually.

BE IT RESOLVED by the Board of Education of the Brookville Local School District (herein the "School District"), County of Montgomery, Ohio, two-thirds of all the members elected thereto concurring:

SECTION 1. That the board of education hereby determines to proceed with the levy and the question of the adoption of said tax renewal shall be submitted to the electors of the School District at the election to be held on May 7, 2013, and if said tax is approved by a majority of said electors such tax levy shall first be placed upon the 2013 tax list and duplicate, for first collection in calendar year 2014.

SECTION 2. That the form of the ballot to be used at said election shall be substantially as follows:

A renewal of a tax for the benefit of the Brookville Local School District **FOR THE PURPOSE OF CURRENT EXPENSES** at a rate not exceeding three and ninety-nine hundredths (3.99) mills for each one dollar (\$1.00) of valuation, which amounts to thirty-nine and nine-tenths cents (\$0.399) for each one hundred dollars (\$100.00) of valuation, for a period of five (5) years, commencing in 2013, first due in calendar year 2014.

D. Resolution determining to proceed to levy a tax in excess of the tenmill limitation (5.5 mills new).

WHEREAS, pursuant to the provisions of Section 5705.21 of the Ohio Revised Code, this board has determined the necessity to levy a tax in excess of such ten-mill limitation for the purpose of current expenses at the rate not exceeding five and one-half (5.50) mills for each one dollar (\$1.00) of valuation, which amounts to fifty-five cents (\$0.55) for each one hundred dollars (\$100.00) of valuation, for a period of five (5) years; and

WHEREAS, the county auditor has certified the total current tax valuation of Brookville Local School District and the dollar amount of revenue that would be generated by the proposed levy annually.

BE IT RESOLVED by the Board of Education of the Brookville Local School District (herein the "School District"), County of Montgomery, Ohio, two-thirds of all the members elected thereto concurring:
